# WAC Effective August 20, 2022:

## WAC 392-700-015: Attendance Period Requirement

"Attendance period requirement" defined as, at minimum, two hours of face-to-face interaction with designated program staff for the purpose of instruction, academic counseling, career counseling, or case management contact aggregated over the prior month.
