#### Land Acknowledgment Reflection

- **Land Acknowledgment (Any)**

*“On behalf of Seattle Central College, I acknowledge the land on which we stand today as the traditional home of the Coast Salish people, the traditional home of all tribes and bands within the Duwamish, Suquamish, Tulalip and Muckleshoot nations. Without them, we would not have access to this gathering and to this dialogue. I ask that we take this opportunity to thank the original caretakers of this land who are still here.”*

- **Labor Acknowledgment (Any)**

*“Today in this Present Moment, we honor the survival, the adaptations, the forced assimilation, and the resilience and creativity of Native peoples – past, present, and future. We encourage participants to consider their responsibilities to the people and land, both here and elsewhere, and to stand in solidarity with Native, Indigenous, and First Nations People, and their sovereignty, cultural heritage, and lives. We recognize that enslaved and indentured peoples were forced into unpaid and underpaid labor in the construction of this country, state and city. To the people who contributed this immeasurable work and their descendants, we acknowledge our/their indelible mark on the space in which we gather today. It is our collective responsibility to critically interrogate these histories, to repair harm, and to honor, protect, and sustain this land. “*

    - I. A big priority was the budget, having a balanced budget and we've accomplished that.
    - II. We also brought transparency to the budget process.

  - I. You were all very engaged, we had a nice alignment with BSTT in the development of Guidelines that informed the budget
- III. Updates from last Board meeting – Informal Authorization of Pay Increases which will have an impact on budgets, still being worked on.
- IV. RAC – Lot of other things happening in addition to this committee work – developed the new Safety Committee as well.
- V. ORCA Cards are being worked on and a new proposal is being worked on to share with the Chancellor
  - I. Analyzing the feasibility of returning to unlimited ORCA cards
  - II. We need internal processes to manage unlimited cards
  - III. Discussing possible flat rate for Part Time or Full Time staff/ faculty
    - I. It's important to consider the usage and needs
  - IV. Still working on final decision but will update you all
- VI. Food Service
  - I. Getting a proposal from Food Trucks Association to address food service on campus
    - I. Food service is returning on campus but the details are being finalized.
    - II. Needs nothing less than \$800 in sales per day.
    - III. Need to decide if the trucks will we be open to the public as well
- VII. Kao's Update
  - I. QTC Update - ID Card Changes
    - I. Working to make it easier for students to update their IDs related to their name changes; it revealed a lot about the other associated IT processes such as on ctclink and emails
    - II. Now Students can change their names in ctcLink, and they're getting a new email with new name.
    - III. More information will be shared this summer and we are acknowledging the hard work by students on this work and seeing the results of their activism.
      - I. Will this also affect the directory? When you go to search new names, sometimes the original name is still in there or in their employee record.
