Rubrics are used to grade the specific grammatical principles that is required in addition to sign production, sentence construction, fingerspelling and fluency.

# Unit 4 Family Narrative 

## STUDENT PROMPT:

- You will be creating a short narrative about your family based on a photo you have. Each photo has a story, and you need to tell the story. I will be evaluating you on the different types of narrative techniques and the ASL grammatical principles you use during the story as well as your vocabulary use.


## Grammatical Principles

1. CONTRASTIVE STRUCTURE: Used to compare and contrast two people.
2. RANKING: used to describe sibling rank by age and to indicate your birth order in the ranking order. You must use your weak hand to list people on.
3. LISTING: used to list people, objects, and other things using very similar sign properties and parameters (parts of the sign) to ranking. You must use your weak hand to list people and objects on.

## Rubric Revision Needed:

The required objective was too narrowly defined
-The ASL curriculum focuses on the nuclear family but does not accommodate modern family configurations.

- Students struggled with creating a narrative that was an accurate reflection of what they wanted to share about their picture.


## Rubric Revision Needed:

- Students did not want to share family pictures for personal reasons or wanted to share pictures of their chosen family.
Students would sometimes skip satisfying the required objective or make choices that did not integrate properly with the narrative.

## Results:

Students were delighted to have more flexibility in which photos they could chose.
They had three options to satisfy that objective and often made better decisions about which one to choose.

## Results:

The narrative itself had a more natural flow, as opposed to seeming as if some of the parts were jammed in there to satisfy some random criteria.
-Students also learned about the LISTING principle which will be taught again later during the same quarter as part of the curriculum.

## Financial Aid Simplification Updates

What is the financial aid (FA) simplification?

- Dept. Of Education (DOE) has overhauled the FA application process to make it more streamlined and efficient for students to receive funds
- New model automatically connects the student's and/or parent's tax info to the student's account

Where are we at currently with the rollout?

- The DOE has delayed the processing of FA awards until mid-May
- Students with parents who do not have a social security number are not able to submit the FAFSA at this time (DOE is working to resolve this issue)


## Financial Aid Simplification Updates

What are the impacts of this delay?

- Seattle Promise milestones may need to be adjusted
- Shorter timeline to process and award FA
- Students need to know their funding to make decisions

What are we doing to mitigate this challenge?

- Connected with our district communication team to rollout FA updates to students
- Working closely with Seattle Public Schools and College Access partners
- Educating and updating our campus and providing additional virtual workshops beginning March

How can you help?

- Please be patient and supportive during the rollout
- Encourage students to attend the virtual workshops
