

CRRSAA and ARP - Higher Education Emergency Relief Funds

Seattle Central College received Higher Education Emergency Relief Fund (HEERF) funds under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan (ARP), and will post the required information to this website and update every quarter.

Seattle Central College is posting this information to comply with the reporting requirements listed below:

(1) An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

(2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Seattle Central College has received \$1,626,299 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA program.

Seattle Central College has received \$5,954,878 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the ARP program.

Seattle Central used a portion of the funds to pay outstanding tuition & fees for all students during spring quarter. Students were required to submit an acknowledgement allowing Seattle Central staff to apply funds directly to student accounts.

All students with a valid FAFSA on file will receive quarterly disbursements of \$530 through spring quarter 2022. Restricted to students with an Expected Family Contribution (EFC) less than, or equal to their financial aid Cost of Attendance.

Students enrolled in the Seattle Promise Program with a zero EFC are receiving a \$500 quarterly disbursement.

The remaining portion of funds are reserved for Seattle Central's Emergency Fund Committee and WorkForce Education Office for emergency student grants. Students must submit applications to be considered.

(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.
