

### **CRRSAA and ARP - Higher Education Emergency Relief Funds**

Seattle Central College received Higher Education Emergency Relief Fund (HEERF) funds under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan (ARP), and will post the required information to this website and update every quarter.

Seattle Central College is posting this information to comply with the reporting requirements listed below:

**(1) An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.**

Seattle Central College signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designed under the CRRSAA and ARP (a)(1) program to provide Emergency Financial Aid Grants to Students.

**(2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

Seattle Central College has received \$1,626,299 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA program.

Seattle Central College has received \$5,954,878 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the ARP program.

**(3) The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter).**

As of Sept 30th, 2021, \$2,053,653 million has been distributed to students.

**(4) The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

As of September 30th, 2021, 4,182 students are eligible to receive funds.

**(5) The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

As of Sept. 30th, 2021, 3,523 students have received funds.

**(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

Seattle Central College prioritized students with exceptional need, including those with unpaid tuition for Spring and fall 2021 (with prior consent), and those with 0 in Expected Family Contribution (EFC).

**(7) Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.**

Seattle Central College's Financial Aid Office built an online application for student consent prior to paying outstanding tuition/fees. The link will be emailed to all that have an outstanding balance and their responses are automatically routed back to Financial Aid.
